WORKING HARD AT INDEPENDENCE

Wyatt and Camirae didn't expect to become parents, but once they recovered from the shock, they have committed to do everything they can to support and care for their son, Skyler. Wyatt has worked three jobs at times to make sure he is not reliant on outside help to support his son. As soon as he discovered he was going to be a father, Wyatt took on night shift work at Walmart, while working days as the manager of Town and Country Kennels. He's now been promoted to a management position at Walmart and has aspirations to return to college. Their mentor, Sondra, tells me that they were always on time for class, even when Wyatt was working round the clock. Born in October, at only 3 pounds and 12 ounces, little Skyler is now topping 10 pounds!

During 2015, CHOICES served:

- 1988 Client Visits (growth of 17% from 2014)
- 143 First Time Clients and 120 clients who began the program in 2014
- 263 Distinct Clients-218 Women (7% increase) and 45 Men (a 15% increase over 2014)
- 97 clients came in suspecting an unplanned pregnancy, of which 44% were considering abortion
- 862 Hours of One-on-One Parenting Mentorship
- \$20,688 in donated Baby Supplies "Purchased" with 3,448 Baby Bucks earned in the Earn While You Learn Parenting Program and in the How To: Dads Fatherhood Program
- \$9,850 in donated goods supplied to other assistance agencies
- \$2,100 in donated goods supplied to clients in collaborating partner programs (Community Partnership classes including GED, LaLeche League, TRE playgroups, Early Head Start, First Visitor Bright by Three and TESSA)
- 51 Volunteers Served Over 4,080 hours working in the CHOICES offices. Another 37 volunteers put in over 4,884 hours making items for the Rocky Mountain Christmas Boutique.

New in Town

Moving to Cripple Creek 24 weeks into her pregnancy, Oceane had no connections and limited resources. CHOICES was instrumental in getting her in prenatal care with an obstetrician. Both parents faithfully attended classes to learn as much as possible in the few short weeks before delivery. Together with their mentor, they

made a birth plan in order to ease Oceane's concerns and be prepared for whatever delivery might hold. Evan never missed a class, even when he had to leave early and report immediately to work. Oceane says, "CHOICES has helped me prepare for my son's arrival. I literally didn't have anything for when my son was born. They helped me prepare myself and my home. CHOICES taught me that it is okay to be scared, but always remember your child is the most important thing." Earning Baby Bucks each week, they were able to provide everything their baby needed, without having to turn to others for help. They can take pride in the safe environment they've provided for little Xzander!

Total Equity: \$427,797


Equity primarily composed of two owned facilities, ultrasound machine and cash reserves.

FINANCIAL SUMMARY:

Each of us on the governing board of CHOICES are monthly donors, including our Executive Director. Spending decisions are weighed carefully, with the goal to maximize impact in the community while respecting the sacrifice that went into every dollar donated from our local citizens. In addition to strong local, individual support, the in-kind donations of diapers, wipes and baby clothing, equipment and supplies help our resources stretch much further.

CHOICES has been very blessed to be able to reduce our overall debt this year. The Cripple Creek mortgage was due for renewal and Park State Bank and Trust lowered our rate by one full percentage point. That facility will be fully debt free in under five years. The next goal is to see the Woodland Park mortgage reduced and paid off much faster than the 18 years of remaining amortization. Please consider joining us in that effort during 2016!

As we begin 2016, I look back with pleasure on the accomplishments of 2015. More than any other year in my tenure with CHOICES, it seems this was the year of clients whose lives were not simply benefitted by CHOICES but fully changed.
